INVESTING EARLY FOR BETTER OUTCOMES

The importance of quality early learning in children's development, especially during the first eight years of life, is certain. Patterns for lifelong learning are set and fundamental building blocks of knowledge, such as language, basic math, and socialemotional skills, are developed.

For children born into poverty, inequalities in learning experiences begin at an early age. By age three, disadvantaged children have heard approximately 30 million fewer words than their more affluent peers. High-quality, early childhood experiences foster the development of cognitive and social-emotional abilities, particularly for disadvantaged youth.

Kohl Children's Museum harnesses the power of play through innovative exhibits and programs based on best practices. We are a safe, magical place where children and adults of all backgrounds and abilities learn, create, and discover.

EXTENDING THE MUSEUM'S Reach and impact


Early Childhood Connections (ECC), the flagship outreach program of Kohl Children's Museum, extends a unique brand of playful learning beyond the Museum's walls. The program connects children and educators in underserved areas with proven educational methods.

ECC provides educators with free, professional training using the same principles behind the Museum's belief in play-based, hands-on learning. Participating teachers and caregivers develop the critical thinking skills of their students by having them conduct an in-depth study of a particular topic. The program also features free family activities at the Museum designed to engage parents in their children's education.

ECC is a recognized model of success. The program is a Chicago Public Schools Preferred Professional Provider and is highlighted in the work of Project Approach expert Judy Harris Helm, Ed. D. Assessments continually show ECC-trained early childhood educators produce statistically significant, positive changes in the use of developmentally appropriate pedagogical methods and strategies.

The impact of **ECC** extends well beyond **Kohl Children's Museum** in Glenview. This map shows the breadth of communities where ECC educators have taught since the launch of the program in 2001. ECC has enriched the lives of underserved children from 90 unique zip codes, from Zion in the north to the far south suburb of Steger.





CARRIE HUGHES served on the Kohl Children's Museum Women's Board for seven years, including as President of the board. Her volunteer leadership continues as a new member of the Board of Trustees. Carrie reflected on the value of giving her time, talents, and financial support to the Museum.

"I went to school for communications, and I got my masters in broadcast journalism. I ended up working for a while for a bank in New York where I did their community relations and events. I also took the minutes for the bank's Board of Trustees, so now I feel like I've come full circle! I used to sit in taking notes, and now I have a seat at the table. It's really exciting for me.

That's what I love about the Museum and volunteer opportunities. You can really grow and try different things. You can experience different things and do things that surprise yourself. And it all goes toward wonderful outreach programs.

When I was President [of the Women's Board], board members who volunteered [at Museum outreach programs] would share their experiences with the rest of the board at meetings. Sometimes they were so touched by their experiences, it brought tears to their eyes. It's nice for people to truly understand where the money is going."

CHRIS HIXON shared the important role Kohl Children's Museum played in the development of his son, Trevor.

"Trevor was born in 2009. At the 18-month mark we noticed that he was not hitting some of the basic milestones that toddlers should be reaching. He received a global developmental delay diagnosis, which was a broad way of saying, 'He's not quite developing typically. He's strong in some areas but not in others.'

That's what started our journey and ultimately led us to a diagnosis of autism spectrum disorder. We were living in [Chicago] at that time... [and] we were seeking opportunities to work on Trevor's development, a lot of which revolves around social and peer interaction.

We discovered that there was a children's museum up north in Glenview. We immediately fell in love with Kohl Children's Museum. It caters to kids across all spectrums, from typically developing kids through kids who have any form of special needs.

Shortly after that first visit we received an email inviting us to come up early on a Sunday [for Everyone at Play]. [This program] had all the benefits of the Museum but in a little more controlled environment. It wasn't as crowded or as hectic, so it provided a really amazing environment to interact without too many distractions.

The Museum became an oasis for us. It was a really fun place for Trevor but it also helped tremendously with his development."

Chris also discussed his involvement with the Museum as a donor and member of Kohl Children's Museum's Development Board: "A friend invited me to the charity golf event [Chip in for Children] to support Kohl Children's Museum. I said, 'Absolutely. I'll be there!' It was a really special, fun event centered around supporting a phenomenal cause. It was great to be able to give back to a place that had given so much to me and my family.

It makes me feel good that I'm able to pay it forward."



EXPLORING SCIENCE, TECHNOLOGY, ENGINEERING, ARTS, AND MATH

From constructing an electrical circuit to creating a vibrating scribble machine, *Tinkering Tuesday* encourages children to do what they do best – let their curiosity take over! In this uber hands-on program, children explore the intersecting worlds of science, technology, engineering, arts, and math (STEAM). Young STEAM explorers build machines and create processes, then figure out what happens when they change those machines and processes. *Tinkering Tuesday* occurs throughout Kohl Children's Museum on our specially designed STEAM Cart.

ROD SMITH, Vice President of Human Resources at **Anixter**, talked about Anixter's sponsorship of *Tinkering Tuesday* and Rod's relationship with Kohl Children's Museum, including serving as a member of the Board of Trustees for three years.

"Technology is behind everything [Anixter] sell[s]. We have a lot of technical products so the STEAM program the Museum was launching made a lot of sense for us. Plus, we're close; we're neighbors. Being in human resources, I have an interest in education. The fit just made a lot of sense for us as a company."

Rod described how Anixter worked with Museum staff to create the one-of-a-kind Kohl Children's Museum Tinkering Tuesday program and corresponding STEAM Cart: "Our technology people and some engineers went over [to the Museum]. It was very collaborative. It was a lot of fun having both the [Museum] team and the Anixter team set up the ideas and take the ideas to fruition with the STEAM Cart."



WAUKEGAN POP UP Experience

Kohl Children's Museum hosted a pop up museum at Urban Edge, a 5,000 sq. ft. storefront gallery located in downtown Waukegan, IL. This pilot program, Kohl Children's Museum in Waukegan, was free of charge to school and childcare groups during weekday hours and to families during evening and weekend hours. The Pop Up Museum included hands-on STEAM activities for children ages three to eight years old and their families.

Among the experiences, large wind tubes and a Bernoulli blower encouraged children to explore airflow, drag, symmetry, and gravity. *Imagination Playground* blocks and magnetic building blocks provided a wealth of collaborative learning opportunities.
